Eligible Entrants	<p>Entry is open to all OTR customers aged sixteen (16) years or older who purchase Fuel using OTR's App v3.3 or above from a Participating Store.</p> <p>Eligible entrants need to download and set up an account with the OTR mobile phone application version 3.3 or above (OTR APP). The OTR App can be downloaded here: https://www.otr.com.au/otr-app/</p> <p>It is a requirement of using the OTR App and entry into this competition, that each entrant must specify and save at least one valid payment method. Entry
